Inter-operability with other UCM applications

VPFM 3.0.3.3 can be installed in an UCM cluster and CPOD 2.0.1 running COM 3.0.2.1, VPS 1.0.3.1 and IPFM 2.0.3.1. VPFM 3.0.3.3 is backward compatible with the above mentioned applications.

VM discovery

• CIM must be enabled on all ESXi hosts for VPFM to discover the VM within the hosts.

8. Installing VPFM 3.0.3.3

VPFM 3.0.3.3 provides a patch installer to replaces the existing files and add new files for new devices support. VPFM 3.0.3.3 can only be installed on top of VPFM 3.0.3 (alias VPFM 3.0.3.1). VPFM 3.0.3.3 cannot be installed as a standalone product. **Please refer to VPFM 3.0.3 GA Install Guide and release notes for more details.**

VPFM 3.0.3.3 cannot be uninstalled. The original patched files are copied to <vpfm-home>/upgrade directory.
