The ExtremeCloud™ Orchestrator vCenter version 3.6.0 Integration Guide outlines procedures for integrating VMware vCenter with ExtremeCloud Orchestrator (XCO). It includes steps for configuring the XCO vCenter service, verifying fabric topology, adding devices to the fabric, creating and managing tenants, and registering vCenter servers as tenants. The guide also details commands for managing vCenter server connections and configurations within XCO. This document is intended for IT professionals managing data center networks using XCO and VMware vCenter.

## Introduction to ExtremeCloud Orchestrator

---

ExtremeCloud Orchestrator (XCO) is a micro-services-based scalable fabric automation application.



### Note

From release 3.2.0 onwards, Extreme Fabric Automation (EFA) is referred to as ExtremeCloud Orchestrator (XCO). The terms EFA and XCO refer to the same product and are used interchangeably.

XCO automates and orchestrates SLX IP fabrics and tenant networks, with support for the following:

- Building and managing non-Clos small data center fabrics and 3-stage and 5-stage IP Clos fabrics
- Managing tenant-aware Layer 2 and Layer 3 networks
- Configuring integration with several ecosystems: VMware vCenter and Microsoft Hyper-V
- Providing a single point of configuration for your entire fabric

XCO consists of core K3s containerized services that interact with each other and with other infrastructure services to provide the core functions of fabric and tenant network automation. For more information, see [XCO Microservices](#) on page 12.

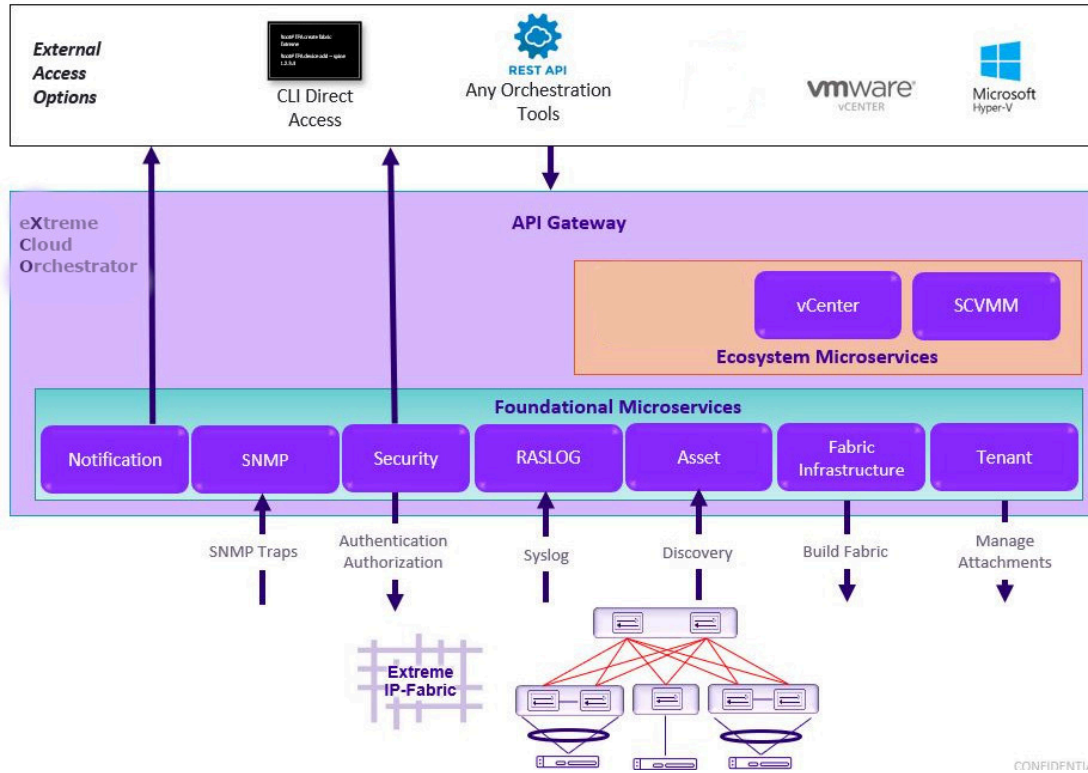
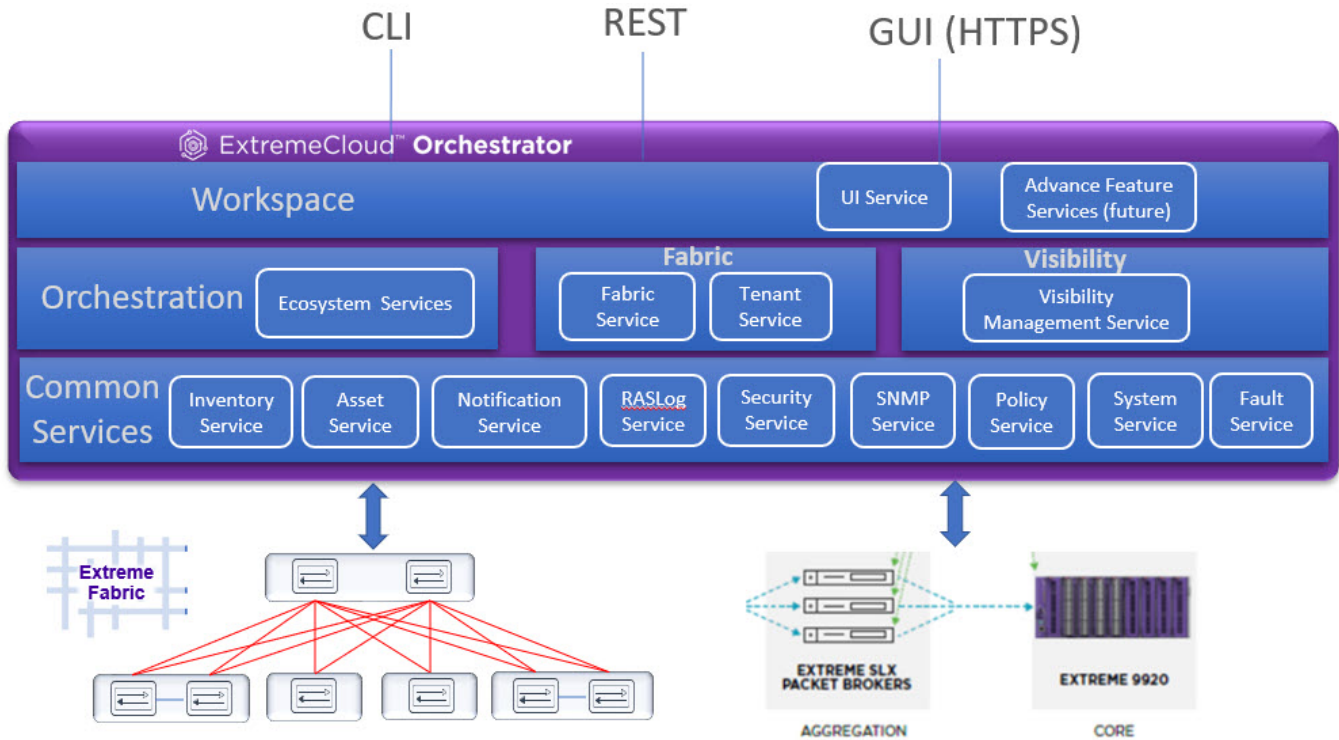


Figure 1: XCO Orchestration

## XCO Microservices

XCO consists of core K3s containerized microservices that interact with each other and with other infrastructure services to provide the core functions of fabric and tenant network automation.



**Figure 2: Microservices in the XCO architecture**

### Fabric Service

The Fabric Service is responsible for automating the fabric BGP underlay and EVPN overlay. By default, the EVPN overlay is enabled but you can turn it off it before provisioning, if necessary. The Fabric Service exposes the CLI and REST API for automating the fabric underlay and overlay configuration.

The Fabric Service features include:

- Support for small data centers (non-Clos)
- Support for 3-stage and 5-stage Clos fabrics
- Support for MCT configuration

Underlay automation includes interface configurations (IP numbered), BGP underlay for spine and leaf, BFD, and MCT configurations. Overlay automation includes EVPN and overlay gateway configuration.

## Tenant Service

The Tenant Service manages tenants, tenant networks, and endpoints, fully leveraging the knowledge of assets and the underlying fabric. You can use the CLI and REST API for tenant network configuration on Clos and small data center fabrics.

Tenant network configuration includes VLAN, BD, VE, EVPN, VTEP, VRF, and router BGP configuration on fabric devices to provide Layer 2 extension, Layer 3 extension across the fabric, Layer 2 hand-off, and Layer 3 hand-off at the edge of the fabric.

## Inventory Service

The Inventory Service acts as an inventory of all the necessary physical and logical assets of the fabric devices. All other XCO services rely on asset data for their configuration automation. The Inventory Service is a REST layer on top of device inventory details, with the capability to filter data based on certain fields. The Inventory Service securely stores the credentials of devices in encrypted form and makes those credentials available to different components such as the Fabric and Tenant services.

The Inventory Service supports the **execute-cli** option for pushing configuration and exec commands to devices. Examples include configuring SNMP parameters or OSPF configurations. This means you can use XCO for SLX-OS commands and push the same configuration to multiple devices.

## Asset Service

The Asset Service provides the secure credential store and deep discovery of physical and logical assets of the managed devices. The service publishes the Asset refresh and change events to other services.

## Notification Service

The Notification Service sends events, alerts, alarms, and tasks to external entities:

- Events: Device events derived from the syslog events received from the managed devices.
- Alerts: Notifications that services in XCO send for unexpected conditions.
- Alarms: A stateful entity that is raised and cleared by the system.
- Tasks: User-driven operations or timer-based tasks such as device registration or fabric creation.

## RASlog Service

The RASlog Service processes syslog messages from devices and forwards notifications to subscribers. For more information, see RASlog Service in the [ExtremeCloud Orchestrator CLI Administration Guide, 3.6.0](#).

## Security Service

The Security Service consists of authentication and authorization features that enforce a security boundary between northbound clients and downstream operations between XCO and SLX devices. The service also validates users and their credentials through Role-based Access Control (RBAC) and supports local and remote (LDAP) login.

You can use LDAP with XCO for user authentication and authorization. Based on the server configuration, XCO provides various options to configure LDAP.

- **TLS Service:** The service enables encrypted communication from XCO to LDAP server.
- **Authentication Service:** The service validates user credentials and supports host user login, local user management and remote (LDAP, TACACS) login.
- **Authorization Service:** The service provides role management and validates the permissions that the user can perform on XCO.

## SNMP Service

The SNMP Service processes SNMP traps from devices and forwards notifications to subscribers. For more information, see XCO as SNMP Proxy in the [ExtremeCloud Orchestrator CLI Administration Guide, 3.6.0](#).

## Policy Service

Policy Service in XCO manages and configures IP prefix lists and route maps on fabric devices. It subscribes to the inventory service to receive events including device registration, device deletion, and changes to previously identified IP prefix lists and route maps.

## System Service

The system service provides options to configure system-level settings, such as supportsave, backup, and feature enablement. It periodically takes a backup of the XCO system.

## Fault Service

The Fault Service raises alerts and alarms when issues are detected to enable system administrators to monitor and troubleshoot.

## Extreme Visibility Manager

Extreme Visibility Manager (Visibility Manager), a Kubernetes-based microservices application, provides centralized device and policy management as part of the Extreme Visibility solution.

Visibility Manager supports several network packet broker devices. Although devices have different functionality and different configuration methods, Visibility Manager seamlessly interacts with all supported devices for simplified management.

You use Visibility Manager to perform much of the same traffic configuration that you might otherwise perform from the command-line interface of your network packet broker operating system. And then you use Visibility Manager to analyze the traffic for insight into issues such as network usage, load-balancing irregularities, and security threats.

Visibility Manager managed objects work together to accomplish most packet broker functions. You configure the objects from the user interface.

## Ecosystem Services

XCO provides one-touch integration with these ecosystems, providing deep insight into VMs, Switches, port groups, and hosts, and the translation of these into IP fabric networking constructs.

### VMware vCenter Service

The vCenter integration provides connectivity between XCO and vCenter using a REST API. XCO does not connect to individual ESXi servers. All integration is done through vCenter. For more information, see the [ExtremeCloud Orchestrator VMware vCenter Integration Guide, 3.6.0](#). Integration support includes the following:

- Registration or deregistration of one or more vCenter servers in XCO
- Updates for vCenter asset details
- Lists of information about vCenter servers
- Inventory integration
- Dynamic updates about Tenant Service integration from vCenter and from XCO services

### Hyper-V

The Hyper-V integration supports networking configuration for Hyper-V servers in a datacenter, manual and automated configuration updates when VMs move, and visibility into the VMs and networking resources that are deployed in the Hyper-V setup. - SCVMM (System Center Virtual Machine Manager) server discovery
- SCVMM server update
- Periodic polling of registered SCVMM servers
- SCVMM server list
- SCVMM server delete and deregister
- Network event handling

## VMware vCenter

VMware's *vCenter* server software enables you to administer and manage your virtual machines and physical servers running VMware's ESXi OS from a single location. ESXi is a type-1 hypervisor that enables you to deploy and manage virtual machines.

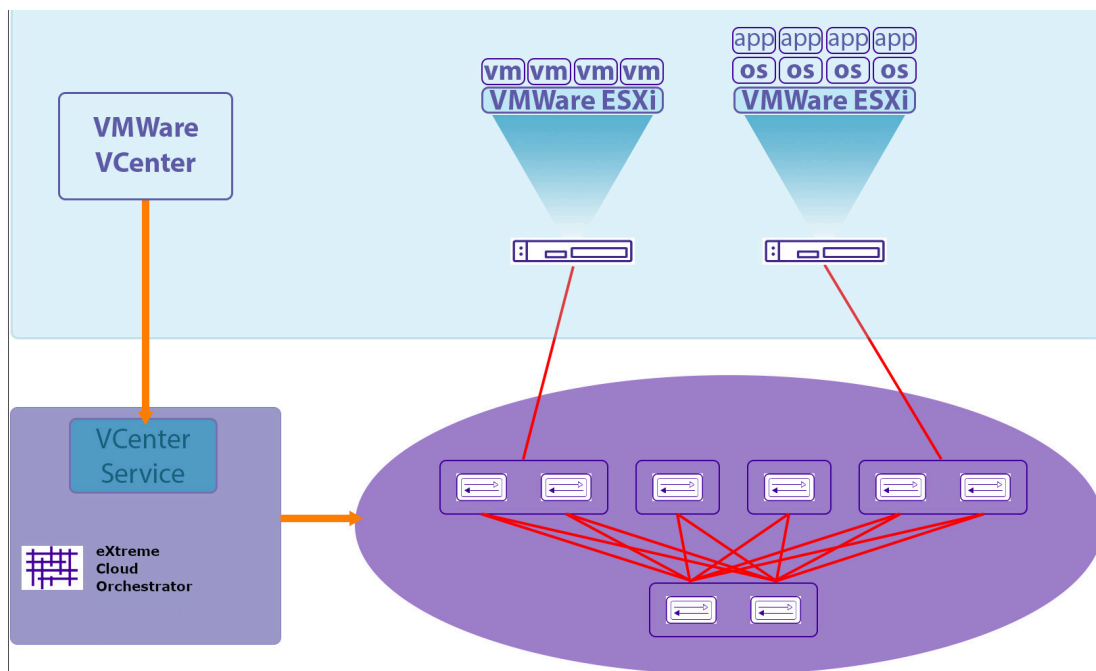
The vCenter software reduces management complexity and time taken to manage complex deployments and reduces day-to-day tasks of managing a large deployment. vCenter Server software enables dynamic provisioning new services, balancing resources and automating high availability of your resources.

## VMware vSphere Client

VMware *vSphere* client is a software that is used to manage VMware's *vCenter* servers. It provides a graphical user interface that enables you to quickly control and manage all virtual machines hosted on your vCenter devices.

## How the XCO vCenter Service Works

Use the ExtremeCloud Orchestrator (XCO) application to automate the configuration of the data center's physical network hardware once you have finished configuring your VMware vCenter Server and the associated virtual machines. XCO then imports VMware's infrastructure and topology information and then applies this to the fabric managed by it.



**Figure 3: vCenter Service Overview**

XCO requires that the physical connection between the VMware ESXi servers and ExtremeCloud devices is working and is configured properly. You should also ensure that the XCO server can access the vCenter Server. The XCO server need not be connected to the individual ESXi servers for this service to work.



Once properly configured, the XCO vCenter service queries the VMware vCenter server to:

- Discover network assets and configurations for the specific VMware vCenter server that will be used.
- Discover the ESXi servers that the specific VMware vCenter server manages. It also discovers the virtual machines and virtual network adapters that are configured on each physical ESXi server.

Discover the physical network adapters that are associated with the virtual machines discovered as mentioned above. All the above information are saved in a local database for use. This stored information is used to verify if there are any changes in the networking assets/configurations for the specified VMware vCenter server.

- Interact with XCO's Inventory service to inquire and find the connections between the physical network adapters and the ESXi servers. It also constantly interacts with the Inventory service to find the port information for any new connections with the ESXi servers.
- Interact with XCO's Tenant Service to create the required tenants and End Point Groups. It also uses the Tenant Service to periodically update the tenants and EPG information to ensure that the information stored locally is in-sync with the actual network topology.

## Supported Versions for XCO vCenter Service

---

XCO vCenter Service supports all platforms and SLX-OS versions.

## Limitations of XCO vCenter Service

---

XCO vCenter Service has the following limitations and restrictions:

- VMware vCenter Server version 6.5 and 6.7 (all releases) are supported. XCO vCenter Service will work with other version than those listed above. However, XCO does not provide support for issues that arise with the use of any versions than listed above.
- XCO requires the open standards LLDP protocol to be enabled under Distributed vSwitch (vDS) to verify the ESXi host topology. The Distributed vSwitch must be configured as "Both" under vDS Discovery Protocol settings so that it can both transmit and receive LLDP messages.
- Currently, ESXi hosts allow LLDP configuration only for the Distributed vSwitch and not the Standard vSwitch. This limitation prevents XCO vCenter Integration from supporting Standard vSwitch deployments.
- XCO does not manage VMware licenses. Users are responsible for VMware vMotion, ESXi, and vCenter licenses.
- XCO cannot detect and fix vCenter connection issues.

## Integrate XCO vCenter Service

---

To integrate your VMware vCenter server with your XCO vCenter service, you need to do the following:

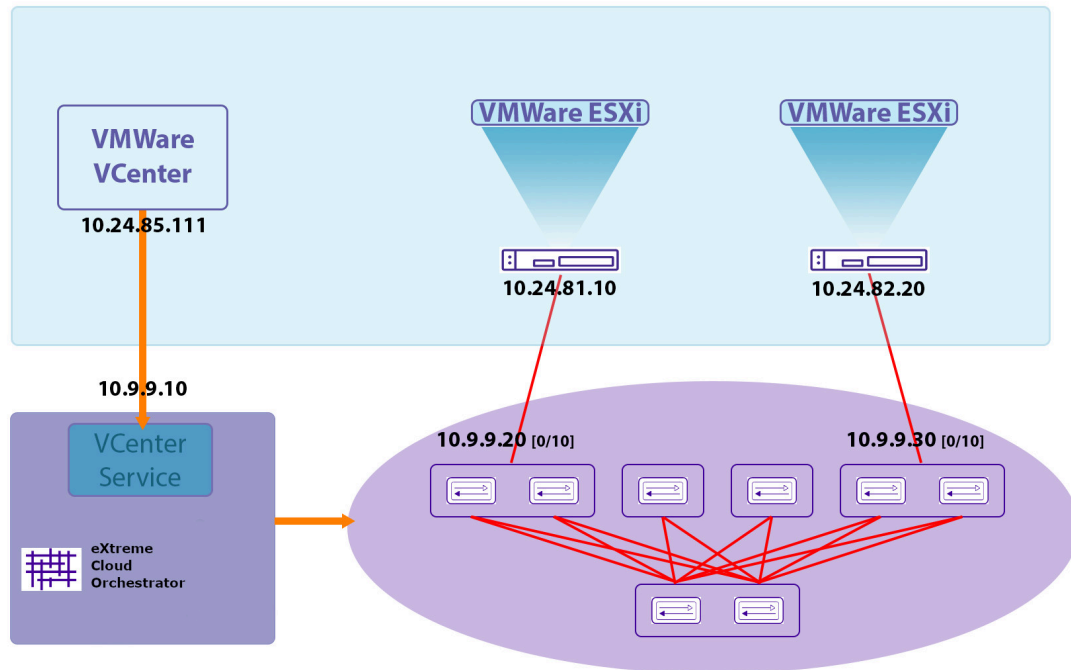
1. Create or modify your fabric as required.
2. Create or modify your tenant information as required.
3. Register your new VMware vCenter Server as a tenant of the fabric.
4. Verify your integration.

## Manage VMware vCenter Server Tenants

The primary tasks of managing your existing VMware vCenter servers as tenants would be to update them periodically or when you add new devices to them. Another task would be to delete these servers when not required.

## Example Network

The following network diagram will be used throughout this section to explain the various configurations.



**Figure 4: Sample Network Diagram**

This table lists the devices, their IP or Port information, and their role within the example network.

IP Address & Port	Device & Role
10.24.85.111	VMWare vCenter Server

## Verify Fabric Topology

### About This Task

Verify that the fabric devices that you wish to add are present in your fabric, and when verified, fetch additional information for each of these devices.

### Procedure

Execute the `efa fabric show` command.

```
efa fabric show
```

The command returns information for all the spine and leaf devices in your fabric.

## Add Devices To Your Fabric

### About This Task

Add devices to a new fabric or to an existing fabric. Do the following:

## Procedure

1. Use the `efa fabric device add` command to add a single device. To add multiple devices in a single command, use the `add-bulk` option instead.

```
efa fabric device add
efa fabric device add-bulk
```

2. Use the `efa fabric configure` command with the `--force` option to force the fabric to update itself by removing and adding all devices that make up the fabric. When the fabric comes up again, it will include the newly added devices.

## Example

The following command adds two leaf devices and a spine device to an existing fabric.

```
$ efa fabric device add-bulk --name efa-fabric-1 --leaf 10.9.9.80,10.9.9.90 --spine

There are no defaults for this command

### Parameters

#### register

Command to register VMware vCenter server as a tenant.

#### update

Command to update the local XCO database with topology changes on the virtual machines managed by the VMware vCenter server.

#### list

Command to list all the VMware vCenter servers registered as tenants with XCO vCenter service.

#### delete

Command to delete specific VMware vCenter server registered as a tenant with XCO vCenter service.

#### links

Command to list the links on a VMware vCenter server or any ESCi device that is managed through this tenant. This command can display link information for physical and virtual NICs and also those NICs that are not connected/used.

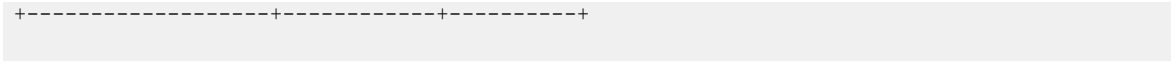

Command to debug any issue with respect to this vCenter tenant.

## efa vcenter delete

---

Deletes the VMware vCenter server registered as a tenant with this XCO instance.

### Syntax

```
efa vcenter delete --host string [ --cleanup-tenants ]
```

### Parameters

**--host** *string*

IP address or hostname of the VMware vCenter server tenant to delete.

**--cleanup-tenants**

When included, the tenants and EPGs associated to the VMware vCenter Server are deleted. When not included, the tenants and EPGs associated with the VMware vCenter Server are retained when the server is removed.

When the `cleanup-tenants` parameter is supplied, the command removes the registered ESXi hosts and EPGs for this VMware vCenter Server tenant.
