Upgrading to a 64-bit Access Control Engine

Beginning in NetSight version 6.3, the 32-bit Access Control engine image is no longer supported. Any Access Control engine currently running a 32-bit OS image must be upgraded to the newer 64-bit image prior to upgrading to Extreme Management Center 8.2.

The following 32-bit engines must be upgraded to a 64-bit image:

- NAC-A-20
- Access Control Virtual Engine

This document provides instructions for upgrading an existing 32-bit Access Control hardware or virtual engine to the new 64-bit Access Control software.

Determining If You Have a 32-bit Access Control Engine

You can use the following information to determine if you are running a 32-bit or 64-bit Access Control engine.

If the Access Control engine is currently running version 4.4 or earlier, it is a 32-bit engine.

For Access Control engines running version 5.0 or later, run the following command from the client command line:

more/etc/os-version

If the contents of the file say "Ubuntu 12.04lts (64bit)", you have a 64-bit engine. If the contents of the file say "Slackware 12.2 (32bit)", you have a 32-bit engine.

Determining if You Have Proxy DNS Enabled

You can use the following information to determine if you have Proxy DNS enabled on your Access Control engine.

Open the /opt/nac/server/config/config.properties file. Check the DNS PROXY ENABLE=true line:

- If the line begins with a #, Proxy DNS is not enabled.
- If the line does not begin with a #, Proxy DNS is enabled.

Upgrading a Hardware Engine

This section describes the procedure to install 64-bit software on a 32-bit Access Control hardware engine.

- 1. On a Windows platform system, go to the Extreme Management Center web page to download the Access ControlEngine Image 64bit (ZIP) file to your system: http://extranet.extremenetworks.com/downloads.
 - After entering your email address and password, follow this path to the Software page: Software & Security > NetSight (NMS) > Software > select a version of Extreme Management Center > Access Control.
- 2. Extract the file to a directory on your system.
- 3. Insert a 4 GB USB flash drive into the USB port on your system and note the drive letter it is assigned.
- 4. Open a Command Prompt window and cd to the directory where you extracted the file. Be sure to use the "Run as administrator" option when launching the Command Prompt. You can access this option by right-clicking on the Command Prompt icon.

- 5. Type make_disk.bat <drive letter>: and press **Enter**. Be sure you have specified the correct drive letter.
 - The files are copied to the USB flash drive. When the copy is complete you see the message "Successfully installed into <drive letter>: Press any key to continue."
- 6. Remove the USB flash drive from your system.
- 7. Insert the USB flash drive into a USB port on the Access Controlengine.
- 8. Press the power button, and then press F2 to go to the BIOS setup.
- 9. Configure the engine to boot from the USB flash drive. The process for each engine hardware type is as follows:

• NAC-A-20

- a. Use the arrow keys and navigate to the Boot Settings option and press Enter.
- b. Go to the Hard-Disk Drive Sequence option and press **Enter**. Ensure that the USB flash drive is listed at top. If it is not, move it to the top.
- c. Hit ESC to exit and select Save Changes and Exit option.

SNS-TAG-ITA

- a. Use the arrow keys to navigate to the Hard-Disk Drive Sequence option and press **Enter**.
- b. Ensure that the USB flash drive is listed at top. If it is not, move it to the top.
- c. Hit ESC to exit and select Save Changes and Exit option.

SNS-TAG-HPA/LPA

- a. Use the arrow keys to navigate to Boot Options and press Enter.
- b. Ensure that the USB flash drive is listed in the Boot Option #1. If it is not, change it to the USB flash drive.
- c. Select Save Changes and Exit option.
- 10. The engine starts booting from the USB flash drive.
- 11. When the boot is complete, the Engine Installation screen appears. Press **Enter** and the installation begins.
- 12. After the installation completes, reboot the engineand then remove the USB flash drive.
- 13. Configure the new 64-bit software using the instructions in Chapter 2, Configuration, in the *IA-A-20 and IA-A-300 Engine Installation Guide*. When

configuring the engine, be sure to use the same IP address and hostname used before. That way you don't have to add and configure a new engine in NAC Manager.

After entering your email address and password, follow this path to the document: Software & Security > NetSight (NMS) > Documentation > Manuals & Release Notes > select a version of Extreme Management Center > Access ControlEngines.

- 14. Complete the following steps if <u>DNS proxy is enabled</u> on the original Access Control Engine, otherwise proceed to <u>Step 15</u>:
 - a. Uncomment the #DNS_PROXY_ENABLE=true line using vi or your preferred editor by deleting the "#" symbol in the /opt/nac/server/config/config.properties file.
 - b. Enter the following command:
 /opt/nac/server/dnsProxy.sh start
- 15. Enforce the Access Control Gateway engine (using NAC Manager) following the software installation operation. Enforcing writes your NAC Manager configuration information to the engine.

Upgrading a Virtual Engine

This section describes the procedure for deploying the 64-bit Access Control engine image on a VMware server. The Access Control virtual engine is packaged in the .OVA file format defined by VMware and must be deployed on either a VMware ESX $^{\text{TM}}$ 4.0, 4.1, 5.0, or 5.1 server, or a VMware ESXi $^{\text{TM}}$ 4.0, 4.1, 5.0, or 5.1 client.

The Access Control virtual engine comes configured with 12 GB of memory, four CPUs, two network adapters, and 40 GB of thick provisioned hard drive space.

It is recommended that you keep your 32-bit image on the VMware server until after you have successfully installed the new 64-bit image. That way, if any problems are encountered, you can fall back to the 32-bit engine.

Determining Your Virtual Engine License Type


Legacy Access Control virtual engine licenses require you to manually enter the number in Extreme Management Center, while current virtual engines automatically apply appropriate licenses.

Access Control engines with legacy licenses must be manually captured and applied to your new virtual engine

NOTE: Licenses for physical engines are also automatically migrated.

To determine if your Access Control engine uses the legacy license model, follow the instructions in this section.

- 1. Open the **Control** > **Access Control** tab in Extreme Management Center.
- 2. Expand the **All Engines** tree in the left-panel.
- 3. Open the **Details** tab in the right-panel.
- 4. Check the **Status** field in the License section of the tab.
 - If the Status shows NAC-V-20 or NAC-VX-5, the license must be <u>captured</u> and <u>applied</u> to your new engine.
 - If the Status shows anything other than NAC-V-20 or NAC-VX-5, the license updates automatically. Continue to <u>Downloading</u>, <u>Installing</u>, <u>and Configuring</u> <u>Your Virtual Engine Image</u>.




Capturing Your Legacy Access Control Engine License

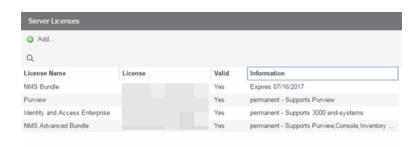
Access Control licenses are based on the number of unique end-systems accessing your network in a 24-hour period. The total number of end-systems included in your license limit include all of the end-systems authenticating on all of your Access Controlengines.

If your virtual Access Control engine uses the legacy licensing model, copy that number from your old engine to apply it to the new engine by following the instructions in this section.

- 1. Ensure your current Access Control license is sufficient for the number of endsystems accessing your network.
 - a. Open the **Control** > **Dashboard** tab in Extreme Management Center and select **System** from the drop-down menu to view your end-system license limit as well as the number of end-systems accessing your network.



- b. Compare the **Total End-System License Limit**, which displays the maximum number of end-systems your license allows, to the **Total End-Systems All Sources**, which displays the end-systems seen on your network to determine if your license is sufficient for the end-system traffic on your network.
- c. Contact Extreme Networks Sales department to change your Access Control licensing, if necessary.
- 2. Copy your existing Access Control license number.
 - a. Open the Administration > Diagnostics tab.
 - b. Select **Server > Server Licenses** in the left-panel. The Server Licenses tab opens in the right-panel.



- c. Copy the entire license that corresponds to the Identity and Access Enterprise row.
- 3. Paste the license in Notepad or another text editor.

Downloading, Installing, and Configuring Your Virtual Engine Image

1. Go to the Extreme Management Center (NetSight) (NMS) web page to download the Virtual Engine 64bit (OVA) image to your local machine where the vSphere client is installed and running:

After entering your email address and password, follow this path to the download page: Software & Security > NetSight (NMS) > Software > select a version of Extreme Management Center > Access Control.

2. Open the vSphere client and deploy the virtual engine. For complete instructions, refer to Chapter 1, Engine Deployment, in the *Extreme Management Center, Access Control, and Analytics Virtual Engine Installation Guide*.

After entering your email address and password, follow this path to the document: Software & Security > NetSight (NMS) > Documentation > Manuals & Release notes > select a version of Extreme Management Center (NetSight) > NetSight and Access Control (NAC) Virtual Engines.

- 3. Once the engine has been deployed, you must configure the engine using the instructions in Chapter 3, Access ControlEngine Configuration, in the *Extreme Management Center, Access Control, and Analytics Virtual Engine Installation Guide.* When configuring the engine, be sure to use the same IP address and hostname you previously used. That way you do not need to add and configure a new engine in NAC Manager.
- 4. Enforce the Access Control Gateway engine (using NAC Manager) following the software installation operation. Enforcing writes your NAC Manager configuration information to the engine.

Applying Your Access Control Engine License

- a. Open the **Administration** > **Diagnostics** tab in Extreme Management Center.
- b. Select **Server > Server Licenses** in the left-panel. The Server Licenses tab opens in the right-panel.
- c. Click **Add** at the top of the tab to open the **Add License** window.
- d. Paste the license you saved in Notepad or other text editor in the window.
- e. Click **OK**.
