4. Notes for Upgrade

For customers upgrading from software versions older than 3.5.4, a series of upgrades are required to prevent configuration corruption under some circumstances. This upgrade path includes the following releases: 2.5, 3.0, 3.1.9, 3.5.4, and 3.6.3. The specific number of upgrades required depends on the currently loaded code version. For instance, if the current version is 3.1.9, one must upgrade to 3.5.4 first and then to 3.6.3.

Problems Resolved in This Release

Radius authentication goes to the secondary server and would not go back to the primary server when there were repeated authentication requests (**Q01296036-02**).

When upgrading to a different code version, the binary configuration was some times corrupted (Q01257870-01).

With snooping enabled, IGMP reports were reflected back when received on a DMLT trunk. This issue caused intermittent connectivity issues to clients or servers sending IGMP reports (Q01291333).

QoS L2-filters were not stored correctly in the ASCII configuration file. (Q01346320)

With a QoS policy configured on a 470, the saved binary configuration file could not be downloaded correctly (**Q01277125**).

When the system uptime wrapped, you could no longer see the whole log by issuing a show log command. (Q01343615-01)

Quotation marks were added to the QoS policy name when the binary configuration file was saved in ASCII format (**Q01277361**).

When EAPoL Port Status changed from Auto to forceUnAuthorize mode due to an unauthorized MAC, an EAP trap was not sent to the log for the intruder MAC (Q01226570-04).

An EAP enabled port could experience connectivity issues even if the port status was authorized. (Q01264826)

When the guest VLAN was enabled on a port and that port was moved to a different VLAN and then disabled/enabled, the port was returned to its original VLAN. (**Q01227523**)
