<b>Bug Reference</b>	<b>Description</b>
<b>SR2K4K-103</b>	<b><i>BCM RX Error messages flooding console</i></b> When the scanning tool Qualys is executed, one of the system task gets suspended which results in the dropping of incoming packets. This in turn triggers the buffers to fill up resulting in console messages flooding up the console. When this happens, the router stops processing traffic and becomes unmanageable.
