

Extreme Wireless 802.11be Wi-Fi 7 Indoor AP5022FX Solution

Overview of AP5022FX

The AP5022FX is an indoor Quad radio Wi-Fi 7 (4x4:4) AP, 6 GHz, 5 GHz band, and 2.4 GHz. It has a dedicated full time sensor (2x2), dual IOT radio with integrated Bluetooth, Zigbee, and Thread capabilities, dual 5 GHz, dual 6 GHz, Multi-Rate ports, internal antennas. The AH-ACC-BKT-AX-TB mount is included. The AP can be installed on a ceiling rail, on a non-standard ceiling, or on a wall.
